I Mangala Rohith, Company Secretary in Practice (ACS 20315, PCS 7438), appointed as scrutinizer for the purpose of remote e-voting and voting at the Sixteenth Annual General Meeting (16th AGM) of Equity Shareholders of United Breweries Limited (the Company), held on September 22, 2015 at Level 1, UB Tower, UB City #24 Vittal Mallya Road, Bengaluru - 560 001, on the below mentioned Resolutions, submit my consolidated report on remote e-voting and voting at the 16th AGM in terms of Section 108 of the Companies Act, 2013 and Rule 20 (4) (xii) of the Companies (Management and Administration) Amendment Rules, 2015:

- 1. The Company had provided remote e-voting facility for its members to exercise their right to vote in respect of business to be conducted at the 16th AGM held on September 22, 2015. The remote e-voting module was kept open during September 19, 2015, 9.00 a.m. till September 21, 2015, 5.00 p.m. I was appointed as scrutinizer for the purpose of scrutinizing the remote e-voting process and ascertaining the requisite majority on remote e-voting carried out as per the provisions of Section 108 of the Companies Act, 2013 (the Act) read with Rule 20 of the Companies (Management and Administration) Amendment Rules, 2015 (the Rules) in respect of business to be transacted at the 16th AGM of the members of the Company.
- 2. The Chairman of AGM allowed poll by polling paper for all those members who are present at the general meeting and have not cast their votes by availing the remote e-voting facility. The Chairman declared that a poll will be taken in respect of the Resolutions contained in the notice convening 16th AGM and I was appointed as scrutinizer for the voting process.
- After the time fixed for closing of the poll by the Chairman, two Ballot boxes kept for polling were locked in my presence with due identification marks placed by me.

- 4. The locked ballot boxes were subsequently opened in my presence and polling papers were diligently scrutinized. The polling papers were reconciled with the records maintained by the Registrar and Transfer Agents of the Company and the authorizations / proxies lodged with the Company. The votes cast through remote e-voting were thereafter unblocked in the presence of two witnesses, Mr M S Sivasankaran and Mr Krishnappa R, not in the employment of the Company.
- 5. The poll papers, which were incomplete and /or which were otherwise found defective have been treated as invalid and kept separately.
