The contribution payable by the employer shall be at the rate of $8\frac{1}{3}$ dearness allowance (including cash value of any food concession) and retaining allowance if any payable to each employee every month. the wontribution shall be calculated on the, basis of the basic wages, dearness allowance etc.; payable during whole month whether paid weekly fortnightly or inonunly basis.

for the purpose of calculation of contribution, the wages may be rounded off to the nearest tupee he 50 paise of more being taken as one rupee and less than 50 paise

Before paying the member his wages you shall deduct the employee's contributions from the wages which together with yor own contribution and administrative charges shall be paid within 15 days of the close of every month in the Accounts of the Fund maintained by the State Bank of India by separate challens in the following manner:

The rate of Administrative charges is 0.85% from 1-10-86 onwards (i.e.) payments made for the month of October, '86 in Novermber, '86) subject to be Note: (1) minimum of s. 5/- o pay i.e. Basic wages, dearness allowance including each value of any food concession and retaining allowance, if any. The rate of administrative charges was 0.37 % of pay prior to 1-10-86 subject to a minimum of Rs. 5/- with effect from 1-12-1978

- it may be noted that if timely deduction are not made from the member's wages, the employer will have to pay both the shares himself, as the recovery of arrears contributions for the back period from the subsequent wages of the employees, is prohibited except when such recovery could note made at the appropriate time due to accidental mistake or clerical error.
- The Family Pension Scheme will be applicable from prospective date i.e 1st of the month of issue of this coverage notice
- Besides making deposits in account numbers 1, 2 and 10 as explained above you are also required to deposit the contributions and adm. charges in Account No. 21 and 22 under the Employees: Deposit linked Insurance Scheme, 1976, in the manner indicated below withi 15 days of the close of each month

To this account will be deposited the countributions 60 0.5% which will be the aggregate of the basic wages, dearness allowance including cash value of the food concession and retaining allowance if any payable to the employees by an employer.

with effect from 16.11.95, (@ 8 1/3 % on total wages, D.A etc) the employers Share of c ntribution may be remitted in Account Number X with effect from 16/11/95.

> In case, the Employees shown in Form 9 were the members of the establishments, private Provident Fund at the commencements of the Scheme, the accumulations in the Provident Fund standing to their credit should be remitted into the State Bank of India to the creadit of the E.P.F. Account No. 1 throught the prescribed challans and the triplicate copy of the challan sent to this office All tho amounts relating to the provident Fund accumulations lying invested in securities should be transfired to the E.P.F. within 1 month by having the securities transferred to the endorsed in favour of the Central Board Trustees, Employees' Provident Fund, and the Securities thus transferred should be sent to this Office. A note containing the instructions in the matter of transfer to these accumulations is enclosed. Cash on hand in relation to the accounts of the private Provident Fund should be remitted within 10 days from the date of receipt of this communication, failing which damages at the prescribed rates will have to be paid by you on the delayed remittances made in each after the due date.
